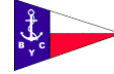

## Notice of Race Commodore's Cup Regatta Saturday August 28, 2010

Specifically: Entry fee changed to \$35.00

**Invitation:** Members of the Bay Yacht Club are invited to participate in the 2010 Commodore's Cup Regatta.

**Rules:** This series will be governed by the rules as defined in the U. S. Sailing Racing Rules of Sailing 2009-2012 (RRS) as may be modified by the Sailing Instructions.

**Classes and Rating Handicaps:** Keel boats PHRF 150 (non-spinnaker) Class. If sufficient boats enter, the Class will be divided by handicap into "A" and "B" divisions. 2010 Corpus Christi Bay PHRF handicaps will be used.

**Entry Fee:** Thirty Five dollars (\$35.) Please make checks payable to "Bay Yacht Club."

**Registration:** Registration at the BYC on Saturday August 28, 2009 from 9:00 to 9:30 a.m. Participants may register in advance by mailing or otherwise delivering a properly completed registration form and entry fee to the BYC Race Committee Chair in sufficient time to be received before the registration deadline of 9:30 a.m. Saturday, August 28, 2010.

**Skippers Meeting:** Skippers meeting at the BYC shortly after close of registration.

**Sailing Instructions:** Sailing Instructions will be available at registration.

**Race Conduct:** Two races are planned. Three races will be sailed if time permits. Races will start and finish at the BYC race committee signal boat anchored outside the Corpus Christi Marina breakwater. The scheduled time of the warning signal for the first race is 11:00 a.m. Signals for each succeeding race will be as prescribed in the Sailing Instructions.

**Prizes:** Trophies will be awarded to the first three finishers in the Class or first three in each Division if the Class is divided. Presentation will be at BYC the evening of the race after the Commodore's Dinner.

1. My boat is equipped to conform with all USCG safety requirements and those of any fleet or association whose rating system will be used for the races in which I compete.
2. I agree to be bound by the Racing Rules of Sailing and all other rules that govern this event.
3. I acknowledge that in consideration of the efforts of the Bay Yacht Club, for acceptance of this entry form as an application to race, and for being allowed to participate in this regatta / race(s) **I DO HEREBY WAIVE AND RELEASE ANY AND ALL CLAIMS I MAY HAVE AGAINST THE BAY YACHT CLUB, ITS OFFICERS, DIRECTORS, OR TRUSTEES AND ITS HOSTS, COMMITTEE MEMBERS, MEASURERS, JUDGES, AGENTS AND REPRESENTATIVES ARISING OUT OF THE ACTIVITIES REQUIRED FOR PARTICIPATION IN THE RACES ON THE WATER, AND I DO FURTHER COVENANT AND AGREE NOT TO SUE OR TO BRING ANY CLAIM OR CLAIMS OF ANY NATURE WHATSOEVER AGAINST THE BAY YACHT CLUB OR ANY OF THE PERSONS AND OFFICES NAMED, OR UNNAMED, ABOVE WHO MAY BE ACTING ON THE CLUB'S BEHALF FOR THESE EVENTS.**
4. I assume any risk of injury arising out of my crew's participation in the race, failure or breakage of my yacht or any of its equipment, or weather conditions.
5. I certify that my crew and I are able to swim and/or will wear appropriate life saving equipment during the race.
6. I will notify the Race Committee immediately upon withdrawal from the race.
7. I own or have chartered the yacht entered.

As Skipper, I acknowledge and agree that the decision to start or to continue a race is solely my responsibility.
