



Deed of Gift

(Modified 11/6/00)

Terry T. Harkrider Outstanding Service Award

PURPOSE: To recognize an outstanding individual or individuals who have made an exceptional contribution to furthering the objectives of the Bay Yacht Club.

NOMINATION: Any member of the Bay Yacht Club may nominate an individual or individuals for this award. All nominations will be received by the secretary of the Bay Yacht Club prior to November 30th of the year in which an individual or individuals are to be recognized for their service.

SELECTION: After receiving nominations, the secretary shall prepare a ballot with the names of the nominees. At the Board of Directors meeting in December, the members of the Board of Directors will each be given a ballot by the Secretary. Each Board member may vote for as many candidates as he or she may feel is deserving of this award. Only those candidates who receive seventy-five percent (75%) of those present and voting shall be awarded the Terry T. Harkrider Outstanding Service Award.

RESULTS OF BALLOTING: All ballots will be collected by the secretary and tabulated with only the secretary and Commodore to receive the results until the installation banquet.

PERMANENT AWARD: The Friends of Terry T. Harkrider will present to the Bay Yacht Club the permanent trophy which will bear the name of the recipients of the award and be displayed in a place of prominence at the Bay Yacht club.

RECIPIENT AWARD(S): The Bay Yacht Club shall be responsible each year for the award(s) given to the recipient(s) of this award and the cost thereof.

MODIFICATION OF DEED OF GIFT: This Deed of Gift may be modified by mutual agreement of Linn Harkrider and the Board of Directors of the Bay Yacht Club at any special or regular meeting of the Bay Yacht Club.
